
Absolute Proof

<u>Introduction:</u> The following is my attempt to fact check this video (click on the title) by Mike Lindell who claims to have absolute proof that the US Presidential election was stolen from the American people and that massive election fraud took place. In order to fact check what he says, I looked for further causal evidence of his claims and researched the people he presents as experts and eye witnesses to the claims he makes in the video. *Dean L. Gano*

<u>Conclusion:</u> There is absolutely no question that massive voter fraud occurred in many of the swing states, but until we get some answers from the legal system, meaning the courts in these states, we simply don't know how serious it was. There are currently only two court cases and one State Senate investigation going on to determine the facts. Hopefully we should know the outcome of these trials and many others in a few months. For me, however, the big question is: what if it is true and they prove the presidential election is invalid and President Biden is indeed party to this illegal activity? Do you really think the Democrats will allow his removal or admit they are controlling the deep state that is behind this? If they don't, then we know this country is doomed to total failure and possibly another Civil War. However, if we are optimistic like Mr. Lindell, the

word will get out and the Democrats will be shown to be the psychopaths that they are and no one will ever trust them again – in which case, everyone wins except the psychos. In any event, our number one priority should be to ensure that the very clear problems with election fraud defined herein will never happen again by changing the election laws and enforcing them.

The Players:

Col. Phil Waldron – Former Information Warfare Officer with the US Government. Looked at Dominion voting machine data in Dallas, Tx. for many years.

Worked with Russ Ramsland who is discussed below.

Worked with Homeland Security in Texas and shows no signs of being a flake. He provides evidence of algorithms put into voting tabulators which multiplied votes. Documented evidence that the Chinese Communist Party (CCP) owns Dominion voting equipment.

No one in the US has access to the Dominion code except the Chinese Dominion folks. Two legal cases looking into these types of voter fraud are ongoing in Michigan and Georgia and the State Senate in AZ is currently doing a full forensic audit of their election.

He has evidence that Foreign Servers in Spain, Germany, Canada, etc. are connected to the voting machines all over the US. He believes this is a coup performed by the CCP with help from inside the US Government. He has affidavits that say people in the DOJ and FBI are involved in this coup. And they have shut down all the investigations into this cyberwarfare. Also, he says the CCP is behind COVID-19 pandemic and government people are helping them propagate this lie.

Russell Ramsland Jr. – Cyber Security Analyst

In 2018 Dallas, TX voting officials came to him and ask him to look at the machines to see if anything shady was going on. They did forensic investigations of the voting machines and found 'horrible errors,' vote shifting, and multiplications and they gave the info to the FBI, State Officials and other Gov. officials and no one would talk to them.

Ron Johnson of the Dept of Homeland Security finally got involved, but no one would listen to them either. Finally got another group from DHS to look at it and they gave it to three private cyber investigators to verify and they did. They found no effective security in the Election Management Systems and that votes were stored in servers overseas. And to make matters worse, 27 states use this same type of system, where the machines are on online.

The DHS folks in Dallas then pushed these findings up the chain of command and after a couple of levels they were told to stand down. This happened in Sept. 2020 before the election, so government officials knew about these crimes and did nothing.

They saw three levels of cheating; Local cheating by voting authorities such as trucking in ballots from out of state and recounting ballots over and over again, etc.; Election

management companies cheating by using multiplication of votes, and overseas servers used to cheat by changing the vote count that goes to the final tally vote counters in the state precincts.

He states that no judges have ever looked at any of his evidence except in Antrim County, Michigan.

In Antrim County, the rejection rate of ballots was 82% which means they have to be adjudicated and someone else gets to change the vote. Normal number is less than 1%. Fulton county had 93.6% adjudication rate.

They have videos and affidavits that the voting machines were indeed connected to the internet.

By analyzing the voter information provided by the counties to everyone online, they found that 50,000 votes were changed in Dallas, TX. They also found and have evidence that this happened all over the nation.

The server in Germany where the votes are being sent records what county it came from and all the info about the ballot. It shows login credentials of every county and can look back into the county and access the entire county database. So, they can go back and log in to the data bases and change them anyway they want.


He says that the US DOJ never investigated the fact that this has been going on long before the 2020 election. He knew about it in 2018 and told them.

<u>Fact Checked:</u> The problem is, none of these claims can be verified and I have trouble understanding how he got his information. He claims in his <u>Michigan affidavit</u> that he got his information from the Dominion/Premier Election Management System (EMS), but no further details of how he got access to voter files. Dominion and other private EMS companies provide the hardware and software, often handle voter registration, hold voter records, partially manage the elections, program counting the votes and report the outcomes. So, this practice, in and of itself, is a very questionable one. Why would a local government allow a private company owned by the CCP so much free access to the most important possession American citizens have – our vote! Also, some research from *PolitiFact* says he is a flake:

Bottom line on this line of fact-checking is the simple FACT that these Election Management Systems have the inherent ability to control how the votes are counted, with no oversight from officials from both sides of the political spectrum. That should never be allowed, but it has been for many years. Kind of makes you wonder why Hillary Clinton kept saying over and over that: "they told me I would win!"

Dr. Shiva - The Man who invented email

He states that voting Machines since 2002 have come with a weighted percentage algorithm capability. As proof he provides a *Diebold Election System* Manual, which is a predecessor of Dominion which explains this weighting system: See below:



Given this fact, all one has to do is ask the simple question: What could possibly be the purpose of this capability? Since our entire election process has always been one man, one vote, there is no purpose for such a feature unless it is to commit election fraud. By publicizing this fact in Suffix County, Mass. the elected politicians there contacted Twitter and told them to take down Dr. Shiva's account. Because he tweeted the fact that his votes were multiplied by 0.666 and he lost in the primary election, he was cancelled. Forensic examination of the voting machines showed this to be a fact, so we have one more data point of how vulnerable our election management systems are. He has a court case pending regarding these violations.

As part of his court case, Dr. Shiva claims that ballot images were deleted shortly after the election, which is against Federal Law and when he told US DOJ about this they did nothing and Bill Barr totally ignored this clear violation of the law. These violations occurred in the September 2020 primaries.

Dr. Shiva also has serious questions about the Coronavirus pandemic and Dr. Fauci's role in it.

Patrick Coleman of Wayne County/Detroit, Ml.


Mr. Coleman confirmed that vote counting machines were connected to the internet and the county officials admitted it. As such there is no way to know if the votes are passed properly to the central authority given the capabilities of the EMS.

Melissa Caroni - IT technician for Dominion at a vote counting center in MI;

She said she was at the voting center for 26 hours watching election officials load ballots into vote counting machines and never saw one vote for Pres. Trump. Also, when the counting machines would jam, they would take the stack of 30 ballots and put them thru the counting machine again and again.

<u>Matt DePerno</u> – Attorney in Antrim county, MI.

Mr. DePerno has filed a lawsuit in Antrim County to contest the validity of the election based on forensic examination of the Dominion voting machines. He said that Antrim County, which is traditionally a strong Republican county came in 65% Democrat and 35% Republican in 2020. Because this is a small county, they did a hand recount of the ballots and found the following vote counts from the various precincts.



This is solid evidence that the vote counting machines changed the votes during the handoff from the precinct to the county center. Check out the numbers at the top of this form. Here is a closer look at three different vote counts. Nov. 5 count was the hand recount. Not sure about the Nov. 21 count.

Notice the 2000 extra **Total Votes Cast** found in the recount on Nov. 5th. No one knows why???

Seeing these major discrepancies, they hired some computer geeks to do a forensic examination of the machines. The following is what they found:



At the onset of the collection process we observed that the initial program thumb drive was not secured in the vault with the CF cards and other thumbdrives. We watched as the County employees, including Clerk Sheryl Guy searched throughout the office for the missing thumb drive. Eventually they found the missing thumb drive in an unsecured and unlocked desk drawer along with multiple other random thumb drives. This demonstrated a significant and fatal error in security and election integrity.

The Dominion voting machine Manual shows you how to connect the machines to the internet – something that is totally illegal. And is probably how all these numbers where manipulated.

On Nov 4th at 11:04 PM, the system files and other source system files were deleted from the machines. A total violation of Federal Law, which requires they be kept for 2 years.


38 counties in Michigan use the same Dominion machines, as do 29 other states in the US.

The following is more from the findings from the forensic examination they did:




 For examples, there were 1,222 ballots reversed out of 1,491 total ballots cast, thus resulting in an 81.96% rejection rate. Some of which were reversed due to "Ballot's size exceeds maximum expected ballot size".

Could it be that the oversized ballots were fake? Humm?




Notice how these machines are clearly designed to provide easy vote manipulation.



8. The tabulation log for the forensic examination of the server for Antrim County from December 6, 2020consists of 15,676 individual events, of which 10,667 or 68.05% of the events were recorded errors. These errors resulted in overall tabulation errors or ballots being sent to adjudication. This high error rates proves the Dominion Voting System is flawed and does not meet state or federal election laws.


Again, one has to ask: "what purpose do these features provide?"



Adjudication means that the ballot is given to a person to determine what the voter intended and then enter the vote without any oversight, no transparency and no audit trail. This is what caused the votes to flip from Republican to Democrat in Antrim county. Normal adjudication is 0.008% nationally.

As you can see from the graph below, that when they saw that Pres. Trump was winning, they pumped up Biden's vote and overcame Trump.

This lawyer is asking the courts to do this kind of forensic examination for every machine in Michigan. Not happened yet.



Perhaps one of the most disturbing findings in all of my research is the incredible efforts to silence anyone who raises questions about voter fraud. For every claim that I investigated, I found many more articles seeking to cancel the claims than there were ones supporting it. Perhaps the best example of this activity can be found in the Michigan Attorney General who threatened all the lawyers and legislators in Michigan with law suits if they continue to discuss or look into the voter fraud. The main reason this is so disturbing is that there is no evidence provided to support their statements. Instead, the messenger is attacked, or the claim is dismissed out of hand.

Mary Fanning - Cyber Security Expert

She says a CIA contractor-turned-whistleblower Dennis Montgomery created an illegal domestic surveillance program known as THE HAMMER, which includes an application for election theft cyberwarfare weapon known as SCORECARD. Mary Fanning's results show 80 million actual votes for Trump

versus 68 Million for Biden. They also claim over 66% of the EMS intrusions came from China.

<u>Fact Checked:</u> Mary Fanning is a questionable source and the source of her information has not been provided to anyone that I can find. However, an independent reporter named Jordan Schachtel reported that she is a hoax in this article: <u>Debunking Hammer & Scorecard, a cheap hoax spawned by a con artist.</u> He says the idea is the work of a serial fraudster by the name of Dennis Montgomery. However, when you look into who he is, you find all kinds of claims making it impossible to know the truth, so this claim is totally questionable, but needs to be further investigated by reputable sources because it is the basis for Mike Lyndell's claim of "absolute truth!"

If these claims are brought to a court, she would have to provide details of how she got the information and right now Dennis Montgomery cannot reveal how the code works because of a DOJ restraining order. They imply that they just got the information by sleuthing thru the internet using SCORECARD, but that would imply that all the local voting precincts had their machines connected to the internet, which is illegal or against secure voting protocol. The only way I think they could get this information is to have access to all the Election Management Systems they speak to. Really? If all these machines were indeed connected to the internet as other evidence shows, then WOW! We have a huge problem with voter integrity in this country.

Also, some reports say Dominion is a US owned company, and others say Dominion voting systems is a Canadian owned Company with Global subsidiaries. It is supposedly owned by Staple Street Capital which is in turn owned by UBS Securities, LLC. And 3 out of 7 of UBS board members are Chinese nationals. The Dominion software is licensed from Smartmatic, which is a Venezuelan owned and controlled company. Dominion servers are located in Serbia, Canada, the US, Spain, and Germany and just the fact that they have servers to provide their service implies they are all connected to the internet.

Another video showed people scanned a batch of ballots over and over. Bringing out boxes of ballots after the counting had supposedly stopped in Georgia.

There are over 1000 sworn affidavits of voter fraud and they have never been seen in a court of law. Why?

Solution:

The US Congress must pass laws that prevent any voting machines from being connected to the internet and that all votes be verified by visual inspection of three people; one from the Democratic Party, one from the Republican Party, and One from an Independent Party. No more machine counting of ballots. Also, all voters must be verified as US Citizens and provide valid ID as registered voters when voting. Only by taking these measures can we be assured the vote has not been stollen like it clearly was in 2020.
