It's Not Cobra Venom

Since our purpose here at Fact-Checked.org is to fact check stories, we had several people ask us about the claim by a Dr. Ardis that SARS-CoV-2 is not a virus but is cobra snake venom and it is being put into our water supplies to spread the disease. He presented this fantastical claim in a Rumble podcast with Stew Peters titled: "Watch the Water," where he interviews Dr. Brian Ardis; a retired chiropractor, who sells "End of Life" medicines.

So, when we investigated Dr. Ardis' claim, we can see he clearly knows nothing about reality. And while that is not surprising, since it is not taught at any level in our education system, his claims just don't make any sense at all. Snake venom is a liquid, not an airborne virus like SARS-CoV-2, so how did it infect millions of people all over the world?

By definition, a virus is an infective agent that typically consists of a nucleic acid molecule in a protein coat and is too small to be seen by light microscopy and is able to multiply only within the living cells of a host.
